Dear Parents:

The California State Legislature passed and Governor Schwarzenegger signed into law SBX5 4 (Romero), Open Enrollment, allowing parents the right to transfer their child/children out of a school that has been identified as one of the 1,000 low-achieving schools in California. As a parent and/or guardian you have the option to transfer your child for the 2011-2012 school year to another school with a higher Academic Performance Index (API) than your current school. This might be a school in the Snowline District, or a school in another district. Applications will be accepted starting January 1, 2011 for the 2011/12 school year.

Please be aware that SBX5 4 states that no local district shall have more than ten percent of its schools on the list of 1,000. This means that not all schools on the list are actually the lowest performing 1,000 schools in the state. Phelan Elementary School has increased their API scores from 643 to 755 over the past 10 years. This is an increase of 112 points! It is our hope that your child/children will remain at Phelan Elementary School and thus benefit from program efforts to improve the school and increase student achievement.

Schools available for your choice within our district are:

- Baldy Mesa Elementary School
- Piñon Hills Elementary School
- Heritage School
- Wrightwood Elementary School

Please realize that you are not required to transfer your child/children. If you choose to exercise the Open Enrollment transfer option, you may obtain an application from your child's school. This application may be completed and submitted to Kathy Sharkey at the Snowline Joint Unified School District Office beginning January 1, 2011.

Transportation costs and/or fees are not included under the Open Enrollment statute and are the responsibility of the parent. To transfer to a school outside of Snowline School District, you will need to request an application from that school or their district office. Additionally, receiving districts/schools may reject admission if they have established policies and guidelines that may include capacity of the school or program.
